DEED means this Section 2 - Deed of Guarantee and Indemnity.

GUARANTOR means the person or persons named in the Schedule hereto.

SUPPLIER means SSH Group Ltd and its wholly owned subsidiaries as described in the SSH Group Credit Application

Overview.

APPLICATION means this SSH Group Ltd - Credit Application

GUARANTEE AND INDEMNITY

The Guarantor hereby irrevocably and unconditionally:

- Guarantees to the Supplier the obligations of the Client to make payment of all monies due now or any time in the future under this Application (**Guarantee**); and
- Indemnifies the Supplier for all losses, liabilities, damages, costs, charges, and expenses (including legal costs and expenses) which may be suffered or incurred by the Supplier that can be attributed to the failure by the Guarantor to perform its obligations under the Guarantee. (Indemnity).

The Guarantor acknowledges:

- That this Guarantee and Indemnity is intended to take effect as a Deed Poll and is for the benefit of Supplier;
- That this Deed Poll may be relied on and enforced by the Supplier in accordance with its terms even though the Supplier
 is not a party to this Deed Poll;
- That this Guarantee is a continuing guarantee that shall extend to the ultimate balance of all monies owed by the Client to the Supplier;
- That this Guarantee and Indemnity is given in consideration of the Supplier granting credit to the Client described in this Application; and
- That the credit limit (if any) provided in this Application shall not affect the scope of this Guarantee and Indemnity.

The Guarantor agrees:

- To charge all real and personal property owned or in the future acquired by the guarantor(s) to secure payment of all monies which are or may become owing under this agreement and or this Deed and consents to an absolute caveat being registered by the Supplier at any time in respect of such land;
- To pay any expenses, costs or disbursements incurred by the Supplier in recovering any outstanding monies, including debt collection agency fees and solicitors' costs, shall be paid by the Guarantor(s);

JURISDICTION

Legal action initiated by the Supplier against the Guarantor(s), arising from non-payment of account for any reason whatsoever, shall be commenced in the Courts of Western Australia and shall remain in the Courts of Western Australia until Judgment where after the Supplier may transfer such judgment to another state of Australia or country.
